#### 1. Introduction

Each school district in Texas is required by Texas Law (<u>Texas Education Code, Title 2, Subtitle F, Chapter 28, Subchapter A, §28.004</u>) to establish and maintain a district-level School Health Advisory Council (SHAC). The School Health Advisory Council of the Hays Consolidated Independent School District (Hays CISD) is specifically authorized by the Board of Trustees in District policies BDF [legal], EHAA [legal], EHAA [legal], and FFA [local].

The report for the 2023-2024 school year lists the meeting dates of the SHAC; the attendance records of its members; a brief description of actions taken by the SHAC; costs related to the SHAC's existence; and anticipated activities for the next year.

#### 2. Background

Each school district in Texas is required in Chapter 28.004 of the Texas Education Code to establish and maintain a district-level School Health Advisory Council. The School Health Advisory Council of the Hays Consolidated Independent School District is specifically authorized by the Board of Trustees in District policies BDF [legal], EHAA [legal], EHAB [legal], EFAA [legal], and FFA [local].

The purpose of the SHAC is to assist the District in ensuring that local community values are reflected in the District's health education instruction. The council's duties include recommending:

- 1. the number of hours of instruction to be provided in:
  - a. health education in kindergarten through grade eight; and
  - b. if the school district requires health education for high school graduation, health education, including physical health education and mental health education, in grades 9 through 12;
- 2. policies, procedures, strategies, and curriculum appropriate for specific grade levels designed to prevent physical health concerns, including obesity, cardiovascular disease, Type 2 diabetes, and mental health concerns, including suicide, through coordination of:
  - health education, which must address physical health concerns and mental health concerns to ensure the integration of physical health education and mental health education;
  - b. physical education and physical activity;
  - c. services;
  - d. parental involvement;
  - e. instruction on substance abuse prevention;
  - f. school health services, including mental health services;
  - g. comprehensive school counseling program under Section 33.005;
  - h. a safe and healthy school environment; and
  - i. school employee wellness;
- 3. appropriate grade levels and methods of instruction for human sexuality instruction;
- 4. strategies for integrating the curriculum components specified by Subdivision (2) with the following elements in a coordinated school health program for the district:
  - a. school health services, including physical health services and mental health services, if provided at a campus by the district or by a third party under a contract with the district;

- b. a comprehensive school counseling program under Section 33.005;
- c. safe and healthy school environment; and
- d. school employee wellness;
- 5. if feasible, joint use agreements or strategies for collaboration between the school district and community organizations or agencies; and

- 6. strategies to increase parental awareness regarding:
  - a. risky behaviors and early warning signs of suicide risks and behavioral health concerns, including mental health disorders and substance use disorders; and
  - b. available community programs and services that address risky behaviors, suicide risks, and behavioral health concerns

7. appropriate grade levels and curriculum for instruction regarding opioid addiction and abuse and methods of administering an opioid antagonist, as defined by Section 483.101, Health and Safety Code.

TEC also states, a majority of the council members must be parents of students enrolled in the district who are not employed by the district. Additionally, SHAC is comprised of community members, businesses, and district representatives. Information from SHAC meetings is posted on Hays CISD website as per TEC and policy requirements.

In addition to following the statutes set forth in TEC 28.004 and Policy BDF Legal and EHAA Legal, the Hays CISD SHAC's mission is to create a school environment that nurtures physical, mental, emotional, and social health so that all students are able to learn at their highest potential. The Hays CISD SHAC has developed bylaws which were last reviewed and updated in September 2023. Membership for the Hays CISD SHAC is to not be more than 30 or less than 10. For the 2023-2024 school year, members may be a mix of voting and non-voting and may serve no more than 2 consecutive terms if willing. The Hays CISD SHAC's bylaws are linked here: SHAC bylaws

#### **Description of Committee Actions**

The Hays CISD School Health Advisory Council met four times in the 2023-2024 school year. All meeting audio recordings and minutes, including actions taken and lists of meeting attendees, are available to the public on the Hays CISD <u>SHAC website</u>.

During each SHAC meeting, the members reviewed the minutes from the previous SHAC meeting, received reports and presentations, discussed action items, and discussed requests for future SHAC agendas.

On September 20, 2023, the SHAC met in person at the Hays CISD Performing Arts Center. Former SHAC members, Lacy Waller, Bonnie Hernandez, Belinda Pizana, Marquet Curl, Stephanie Hooton, Stephanie Jamail, and Kelly Dean were honored for their service by receiving a Superintendent's Coin of Excellence from Dr. Wright. A review of the purpose and role of SHAC was provided by Megan Benthall. Information from the July 2023 meeting regarding athletic trainers at the middle school was provided by Dusty Gibbs, Assistant Athletic Director. The SHAC bylaws were presented for proposed amendments in regard to term limits and other general updates. The motion passed with 16 for and 0 against. The meeting dates were discussed and amended. The motion passed with 16 for and 0 against. The executive committee was formed with Alex Zavala, Megan Benthall, and Krista Deshayes. The physical activity (required by TEC 28.004) was formed with Ali Valdez, Robin Goffena, and Whitney Lorentzen. During open discussion, there was a request for committee formation for mental health and wellness. The mental health committee was formed with Teresa Tobias, Krista Deshayes, Robin Goffena, Ali Valdez, Tia Horton, and LindaRae Johnson. The wellness committee was formed with Thomas Stone, Megan Benthall, and Kristen Cearbaugh.

On November 15, 2023, the SHAC met in person in the Kunkel Room of the Old Buda Elementary Upper Campus. Cynthia Luna, Community Outreach Coordinator with Dell Children's Health Plan gave a brief overview on Dell Children's Health Plan and asked for assistance with getting information to the campus PTAs to present on health insurance coverage options for children. Jeri Skrocki provided an update on the district's Fighting Fentanyl campaign. Megan Benthall gave a presentation to introduce Tucker's Law to the SHAC and the SHAC's duty in recommending curriculum specific to fentanyl awareness for grades 7 & up. Subcommittees gave a brief update to any meetings or work that is being done.

On February 21, 2024, the SHAC met in person in the Kunkel Room of the Old Buda Elementary Upper Campus. Whitney Self gave an update on the CATCH grant that the district has received. The grant will allow the district to get updated materials for the CATCH curriculum and get PE and health teachers trained. Megan Benthall, Derek McDaniel, Emily Herrin, and Shelly Plumley introduced the curriculum created by the district to satisfy HB 3908 (Tucker's Law). The Tucker's Law curriculum was reviewed and recommended by the SHAC with 13 votes for, 0 against. The physical activity subcommittee provided a brief update on the PHIT center application for CRES and a survey for teachers to complete. The child nutrition subcommittee provided an update on the social media posts, roving chef event, and national breakfast week.

On May 15, 2024, the SHAC met in person in the Kunkel Room of the Old Buda Elementary Upper Campus. Meeting dates/times were discussed and voted on for the 2024-2025 school year with 10 votes in favor, 0 votes against. The following dates were chosen: September 18, 2024, November 13, 2024, February 12, 2025, and May 7, 2025. Angelica Solis and Thomas Stone provided an update on the Child Nutrition initiatives for promoting good nutrition. The initiatives discussed included Career Day, Roving Chef, Menu Madness, Flavor Fest, and the Green Bronx Machine. Suzanne Van Velson with the CATCH

Global Foundation gave an overview of the CATCH coordinated school health curriculum and the different types of sponsorships that are available for school districts that have implemented the CATCH curriculum. The mental health subcommittee provided an update after the Tom Green bus accident on the initiatives put in place to support students. The physical activity subcommittee also provided an update on the survey to send to teachers regarding physical activity.

#### SHAC recommendations

The SHAC recommends the district created curriculum to satisfy the requirements set forth in HB 3908 (Tucker's Law) for grades 6-12.

The SHAC will continue to focus on mental health awareness for students.

The SHAC will continue to focus on physical activity for elementary schools to ensure the minimum of 135 minutes/week are met.

The SHAC will continue to focus on overall wellness of the district by utilizing the Hays CISD's wellness plan.

#### **Committee Costs**

The Hays CISD Student Health Services provided funds for a substitute teacher for Whitney Self for all in person meetings and for her to attend the Austin Area Health and Wellness Community of Practice Meeting. The total cost incurred by the SHAC for the 2024-2025 school year was \$642.36.

### 4. Committee Planning – 2024-2025

#### **Committee Members 2024-2025**

The proposed Hays CISD SHAC membership list was compiled for the Hays CISD Board of Trustees for the August 2024 meeting as noted in the Hays CISD SHAC bylaws.
