#### 1. Introduction

Each school district in Texas is required by Texas Law (<u>Texas Education Code, Title 2, Subtitle F, Chapter 28, Subchapter A, §28.004</u>) to establish and maintain a district-level School Health Advisory Council (SHAC). The School Health Advisory Council of the Hays Consolidated Independent School District (Hays CISD) is specifically authorized by the Board of Trustees in District policies BDF [legal], EHAA [legal], EHAA [legal], and FFA [local].

The report for the 2022-2023 school year lists the meeting dates of the SHAC; the attendance records of its members; a brief description of actions taken by the SHAC; costs related to the SHAC's existence; and anticipated activities for the next year.

#### 2. Background

Each school district in Texas is required in Chapter 28.004 of the Texas Education Code to establish and maintain a district-level School Health Advisory Council. The School Health Advisory Council of the Hays Consolidated Independent School District is specifically authorized by the Board of Trustees in District policies BDF [legal], EHAA [legal], EHAB [legal], EFAA [legal], and FFA [local].

The purpose of the SHAC is to assist the District in ensuring that local community values are reflected in the District's health education instruction. The council's duties include recommending:

- 1. the number of hours of instruction to be provided in:
  - a. health education in kindergarten through grade eight; and
  - b. if the school district requires health education for high school graduation, health education, including physical health education and mental health education, in grades 9 through 12;
- 2. policies, procedures, strategies, and curriculum appropriate for specific grade levels designed to prevent physical health concerns, including obesity, cardiovascular disease, Type 2 diabetes, and mental health concerns, including suicide, through coordination of:
  - a. health education, which must address physical health concerns and mental health concerns to ensure the integration of physical health education and mental health education:
  - b. physical education and physical activity;
  - c. services;
  - d. parental involvement;
  - e. instruction on substance abuse prevention;
  - f. school health services, including mental health services;
  - g. comprehensive school counseling program under Section 33.005;
  - h. a safe and healthy school environment; and
  - i. school employee wellness;
- 3. appropriate grade levels and methods of instruction for human sexuality instruction;
- 4. strategies for integrating the curriculum components specified by Subdivision (2) with the following elements in a coordinated school health program for the district:
  - a. school health services, including physical health services and mental health services, if provided at a campus by the district or by a third party under a contract with the district;

- b. a comprehensive school counseling program under Section 33.005;
- c. safe and healthy school environment; and
- d. school employee wellness;
- 5. if feasible, joint use agreements or strategies for collaboration between the school district and community organizations or agencies; and

- 6. strategies to increase parental awareness regarding:
  - a. risky behaviors and early warning signs of suicide risks and behavioral health concerns, including mental health disorders and substance use disorders; and
  - b. available community programs and services that address risky behaviors, suicide risks, and behavioral health concerns

7. appropriate grade levels and curriculum for instruction regarding opioid addiction and abuse and methods of administering an opioid antagonist, as defined by Section 483.101, Health and Safety Code.

TEC also states, a majority of the council members must be parents of students enrolled in the district who are not employed by the district. Additionally, SHAC is comprised of community members, businesses, and district representatives. Information from SHAC meetings is posted on Hays CISD website as per TEC and policy requirements.

In addition to following the statutes set forth in TEC 28.004 and Policy BDF Legal and EHAA Legal, the Hays CISD SHAC's mission is to create a school environment that nurtures physical, mental, emotional, and social health so that all students are able to learn at their highest potential. The Hays CISD SHAC has developed bylaws which were last reviewed in 2021. Membership for the Hays CISD SHAC is to not be more than 30 or less than 10. For the 2022-2023 school year, members may be a mix of voting and nonvoting and may serve multiple terms if willing. ## **Description of Committee Actions**

The Hays CISD School Health Advisory Council met seven times in the 2022-2023 school year. All meeting audio recordings and minutes, including actions taken and lists of meeting attendees, are available to the public on the Hays CISD <u>SHAC webpage</u>.

During each SHAC meeting, the members reviewed the minutes from the previous SHAC meeting, received reports and presentations, discussed action items, and discussed requests for future SHAC agendas.

On September 21, 2022, the SHAC met virtually. The SHAC report to the School Board was reviewed and discussed. Jeri Skrocki provided an update on the opioid crisis within our district, and Megan Benthall discussed training development for staff for Narcan administration. Emily Herrin provided an overview of the Health curriculum on Edgenuity and sent out links to all SHAC members to review the curriculum. Term limits were discussed in open discussion; several members spoke up in opposition about limiting the number of terms a SHAC member can hold.

On October 29, 2022, the SHAC met virtually. A review of the purpose and role of SHAC was provided by Megan Benthall as requested from the previous meeting. Emily Herrin and Derek McDaniel were present to answer any questions regarding the health curriculum on Edgenuity. The online platform Edgenuity was approved for online health curriculum. Wellness plan review and discussion was provided by Megan Benthall for voting and approval at the November meeting. Discussion was had regarding appropriate SEL curriculum and differences amongst campuses.

On November 16, 2022, the SHAC met in person at the Curriculum and Instruction Annex in the large training room and lunch was provided by Hays CISD Student Health Services. In the November meeting, child nutrition information was presented as requested by the SHAC for the numbers of students receiving free and reduced lunch. Amendments to the wellness plan were adopted to include goals for opioid antagonists and opioid education. The motion passed with 10 for and 1 against. Tracey Mayhue and Maritza Gonzalez provided an overview to social emotional learning initiatives within the district. Questions were asked about special education and their approach with social emotional learning. Patricia Esteves with special education was present to address the questions specific to Special Education..

The meeting on January 18, 2023 was cancelled due to no agenda items and requests for information. On February 15, 2023, the SHAC met virtually. Texas State student, Kate Powers, was present to discuss the Youth Risk Behavior Survey. The information presented provided resources for the SHAC to look at previous YRBS survey results. It was discussed that the YRBS survey information from previous years supported the Girl Talk/Boy Talk event.

On April 19, 2023, the SHAC met virtually. Megan Benthall provided an introduction to Girl Talk/Boy Talk to the new members of the SHAC. The event was held on May 3, 2023 at Hays High School. The panelists were Dr. Nicole Hartman, Pastor Jessica Cain, Erica Gallardo, Dr. Michael Grady, Father Mike Woods, and Eddie Reyes. YRBS was not conducted due to Texas State not having resources on scale Hays CISD needed to implement the survey. Megan Benthall also provided an update on Wellness Surveys that were sent out to campuses to gather data on the initiatives and goals from the Wellness Plan.

On May 17, 2023, the SHAC met in person at the Curriculum and Instruction Annex in the large training room and lunch was provided by Hays CISD Student Health Services. The SHAC selected meeting dates

for the 2023-2024 school year. The SHAC voted to hold a 3<sup>rd</sup> in person meeting. There was discussion about proposing bylaw changes in the July meeting to reflect more accurate meeting times and requiring members attend at least 2 of 3 in person meetings in addition to other attendance requirements. Whitney Lorentzen was present to review physical activity minutes for elementary and middle schools. The SHAC did not amend the current recommendation of physical activity minutes. Amy Anderson with Hill Country Mental Health provided an introduction to Youth Mental Health First Aid training for staff at Hays CISD.

On July 19, 2023, the SHAC met virtually. Megan Benthall provided an update on the proposed membership list for 2023-2024 school year and reviewed the 2022-2023 school year report to the board. Alex Zavala was voted as Parent Co-Chair to the SHAC. The vote was held virtually. Tina Madrigal with St. David's Foundation presented on increased opportunities for our partnership with the St. David's dental van and providing dental education to our students while increasing physical activity.

#### **SHAC** recommendations

The SHAC recommends a continued focus on mental health awareness and encouraging staff members to attend a Youth Mental Health First Aid Training provided by Hill Country Mental Health.

The SHAC will continue to focus on physical activity for elementary schools to ensure the minimum of 135 minutes/week are met.

The SHAC will continue to focus on the opioid crisis and interventions within the community.

The SHAC will continue to focus on overall wellness of the district by utilizing the Hays CISD's wellness plan.

#### **Committee Costs**

The Hays CISD Student Health Services provided lunch to all attendees at the in-person meetings in November 2022 and May 2023. The total cost for food was \$803.50. The Hays CISD Student Health Services provided funds for a sub for Whitney Lorentzen for the May 2023 meeting. The total cost of subs was \$125.00. The total costs incurred by the SHAC for the 2022-2023 school year was \$928.50.

### 4. Committee Planning – 2023-2024

#### **Committee Members 2023-2024**

The proposed Hays CISD SHAC membership list was compiled for the Hays CISD Board of Trustees for the June meeting as noted in the Hays CISD SHAC bylaws. The agenda item was pulled and more

information was requested by the Hays CISD Board of Trustees. The Hays CISD SHAC District Co-Chair and Chief Academic Officer answered the questions posed by the Board of Trustees and continued to work on recruitment efforts for under-represented areas of the district. For the 2023-2024 School year, the Hays CISD SHAC voted Alex Zavala on July 19, 2023 to serve as Parent Co-chair, and Megan Benthall, Director of Student Health Services will continue to serve as District Co-chair per the Hays CISD SHAC bylaws. The Hays CISD Board of Trustees appointed the membership below on August 28, 2023:
